a. Comments by Executive Director - Ben Russo

Ben Russo provided the following updates during the meeting:

- **Bond Issuance**: Attorneys and advisors have been hired to assist with the overall process of bond issuance
- **Highwater Hardstand Project**: Bids have been issued to add stone to the highwater hardstand.

- **Bridge Project**: The bridge project is progressing well, with anticipated completion in early November.
- Avant Production Facility & Drainage Ditch Project: Expected to be completed in November.
- **FTZ Project**: The project is on track for completion in December.
- Land Acquisition:
 - The City of Alexandria has started the surplus process for the 9+ acres CLRP intends to purchase, with boring plans.
 - A small parcel of land (approximately 1 acre) between the old D&J Construction and Rinker Materials area is owned by Northport Properties. Discussions are ongoing with Steve Ayers and Bryan Bossier regarding acquisition to ensure levee access.

• Funding Updates:

- o Capital Outlay funds, once awarded, can be utilized immediately.
- o Port Priority funds will only be distributed when fully funded.
- Audit: CLRP received another clean audit. Special appreciation was extended to Executive Assistant Stephanie Ryland for her dedication to maintaining compliance with proper procedures throughout the year.

These updates reflect the continued progress and strategic efforts being made across multiple projects at the port.
